### Tentative Comprehensive Course Schedule

We will begin online with a diagnostic test and some high value select NJ Attorney General Guidelines videos. In addition to the Attorney General Guidelines, we will review select Case Law & highly testable Criminal Code 2C. You will be able to access these online videos whenever it's convenient for you. They will be immediately available after you register for the course. Formal in-person course classes & online testing for the sergeant's promotional exam are scheduled to run from Oct to Feb. We will be holding classes in both South & North Jersey. In-person classes will start Oct 19th at the South location, which usually meets SATURDAY & SUNDAY, 9:00 am to 1:00 pm or 6:00 pm to 10:00 pm. Starting Oct 22nd, the North location usually meets TUESDAY & WEDNESDAY, 9:00 am to 1:00 pm or 6:00 pm to 10:00 pm. The night classes at the South & North locations are an exact repeat of the day class.

Schedule is subject to change and modification based on location availability and any NJ Civil Service test schedule changes
