### **Tentative Comprehensive Course Schedule**

We will begin online with some high value select NJ Attorney General Guidelines videos. In addition to the Attorney General Guidelines, we will review select Case Law and highly testable Criminal Code 2C. You will be able to access these online videos whenever it's convenient for you. They will be immediately available after you register for the course. Formal **in-person course classes** & online testing for the sergeant's promotional exam are scheduled to run from Oct to Feb. We will be holding classes in both South and North Jersey. In-person classes will start **Oct 19th** at the South location, which usually meets **SATURDAY & SUNDAY, 9:00 am to 1:00 pm or 6:00 pm to 10:00 pm**. Starting **Oct 22nd**, the North location usually meets **TUESDAY & WEDNESDAY, 9:00 am to 1:00 pm or 6:00 pm to 10:00 pm**. The night classes at the South and North locations are an exact repeat of the day class.
