## **2024 Police Lt, Capt, Deputy Chief, and Chief Comprehensive Course Schedule**

We will begin online with some high value select NJ Attorney General Guidelines videos. In addition to the Attorney General Guidelines, we will review select Case Law and highly testable Criminal Code 2C. You will be able to access these online videos whenever it's convenient for you. They will be immediately available after you register for the course. Formal **in-person course classes** & online testing for the lieutenant, captain, deputy chief, and chief's promotional exam are scheduled to run from July to Oct. We will be holding classes in both South and North Jersey. In-person classes will start **July 13th** at the South location, which meets **SATURDAY & SUNDAY, 9:00 am to 1:00 pm or 6:00 pm to 10:00 pm**. Starting **July 17th**, Wednesday, the North location will have the first in-person class. The North location meets mostly **TUESDAY & WEDNESDAY, 9:00 am to 1:00 pm or 6:00 pm to 10:00 pm**. However, there are some north sessions that meet on different days. Sessions 29, 30, 76 and 77 meet on **Wednesday & Thursday (July 17 & 18 and Sept 18 & 19)**. **Sessions 54, 55, 70 & 71 meet on Thursday & Friday (Aug 22 & 23 and Sept 12 & 13)**. The night classes at the South and North locations are an exact repeat of the day class.

Schedule is subject to change and modification based on location availability and any civil service test schedule changes.
