## 2025 New Jersey Police Sergeant, Lieutenant, Captain, Deputy Chief, and Chief Comprehensive Review Course Schedule

We will begin with **online access** to a selection of high-value **New Jersey Attorney General Guidelines** videos. In addition to these guidelines, the online platform will include reviews of **select Case Law** and **highly testable sections of the Criminal Code (2C)**. These videos will be available **on-demand**, allowing you to study at your convenience. Once you register for the course, you will gain **immediate access** to these materials.

Our **formal in-person classes** for the **Sergeant, Lieutenant, Captain, Deputy Chief, and Chief's promotional exams** will begin in **July**, with classes offered in both **South and North Jersey**.

- **South Location:** In-person classes start **Saturday, July 19**, and will be held on **Saturdays from 9:00 AM to 5:00 PM**.  
The South Saturday class is then repeated in the North over 2 four-hour days.
- **North Location:** In-person classes begin **Wednesday, July 23**, and will be held on **Wednesday & Thursday** at two time slots:
  - **Day session:** 9:00 AM – 1:00 PM
  - **Evening session:** 6:00 PM – 10:00 PM (an exact repeat of the day session)
